An Act to Amend the Chartered Institute of Stockbrokers Act Cap. C9, Laws of the Federation of Nigeria, 2004 to Increase the Penalties Prescribed;

and for Related Matters.

[20th Day of December, 2016]

Commencement.

ENACTED by the National Assembly of the Federal Republic of Nigeria—

1. The Chartered Institute of Stockbrokers Act Cap. C9, Laws of the Federation of Nigeria, 2004 (in this Act referred to as "the Principal Act") is amended as set out in this Act.

Amendment of Cap. C9 LFN. 2004.

2. Section 16 of the Principal Act is amended—

Amendment of Section 16.

- (a) in subsection (5) (a), by substituting for the expression, "N1,000" in line 1, the expression, "N500,000" and
- (b) in subsection (6), by substituting for the word, "person", in line 4, the word, "official".
- **3.** This Act may be cited as the Chartered Institute of Stockbrokers (Amendment) Act, 2016.
